Regular Meeting: Opened by Chairman Marsh at 6:00 p.m.

Approval of Meeting Minutes: Chairman Marsh said he would entertain a motion to approve the minutes from the July 26th meeting. Commissioner Wallace made a motion to approve the minutes. Commissioner Vasquez seconded the motion, all in favor, motion passed.

Amendments to Agenda: None

Introduction of New Planning & Zoning Commissioner: The City of Shoshone Planning and Zoning Commission had 2 vacancies on the board. Commissioner Chuck Rutler submitted his letter of resignation in August due to being unable to attend most meetings because he works out of town all the time now. Commissioner Justin Schoolcraft's last planning and zoning meeting was the July 26th meeting. Since that meeting, he was appointed to fill a vacancy on the City Council and can no longer be on the planning and zoning commission.

Councilman Dale Sluder had mentioned, at some point in the last month, that Tim Ridinger may be willing to fill one of the vacancies. Jennifer Rumble, planning and zoning administrator, contacted Tim and he agreed to fill one of the vacancies. Mayor Reese and the City Council appointed Tim to the planning and zoning commission at the August 16th City Council meeting.

Tim has prior experience with the City of Shoshone. He has been on the City Council before and he was also the mayor a long time ago. He was also a state legislator for 10 years. He has lived in Shoshone for over 40 years.

Other Business: Commissioner Brass's term has expired for being a commissioner on the planning and zoning commission. Jennifer Rumble, contacted Rebecca Wood, Lincoln County Commissioner, about having them reappoint Connie, since Connie is the area of impact commissioner. Rebecca spoke to Connie and Connie does want to continue on as a commissioner for the City of Shoshone Planning and Zoning Commission. Rebecca will put it on their agenda to reappoint Connie.

Chairman Marsh talked about going back through the planning and zoning ordinance and the subdivision ordinance, as a refresher. We are still waiting on the planning and zoning ordinance revision to be reviewed by the City Attorney. It has been 2 years since we sent it to her.

Jennifer Rumble is going to print out the revised, but not adopted, planning and zoning ordinance for everyone to have a copy of at the next meeting.

Meeting Adjourned: Chairman Marsh said he would entertain a motion to adjourn the meeting. Commissioner Ridinger made a motion to adjourn the meeting. Commissioner Vasquez seconded the motion, all in favor, motion passed. Meeting adjourned at 6:19pm.
